FOR EMPLOYEE APPLICANTS

This is "seasonal, at will" employment. You are free to terminate your employment with the Circle Ten Council at any time, with or without reason, and the Circle Ten Council has the right to terminate your employment at any time, with or without reason. Although the Circle Ten Council may choose to terminate employment for cause, cause is not required. This is called "at will" employment.

All offers of employment are contingent on verification of your right to work in the United States. Before your first day of work you will be asked to provide original documents verifying your right to work and to sign verification forms required by federal law. If you at anytime cannot verify your right to work in the United States, the Circle Ten Council may be obliged to terminate your employment.

All staff members over the age of 18 must complete a criminal background check, BSA Youth Protection Training, and Weather Hazards Training. All staff members regardless of age must present a current BSA Annual Health and Medical Record (Parts A, B, and C) #34605 upon arrival on the first day of camp.
